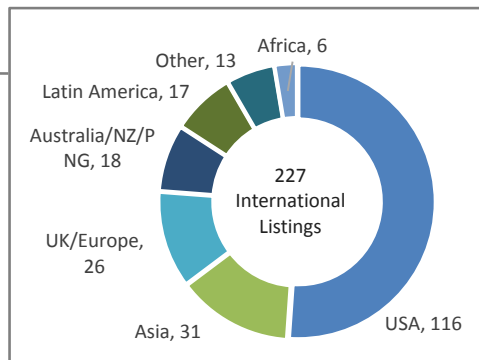

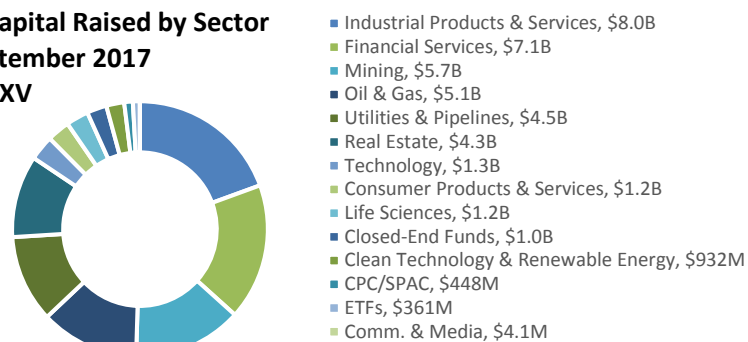

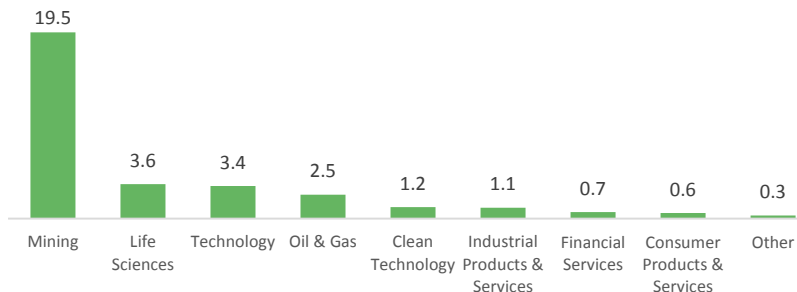
Comparison of Major Index Performance -- YTD September 30, 2017 (Source: Capital IQ)



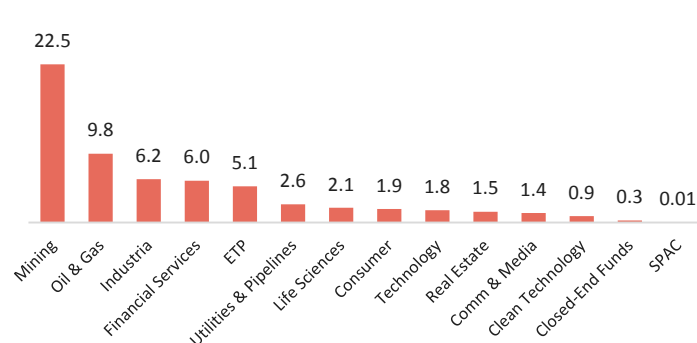
