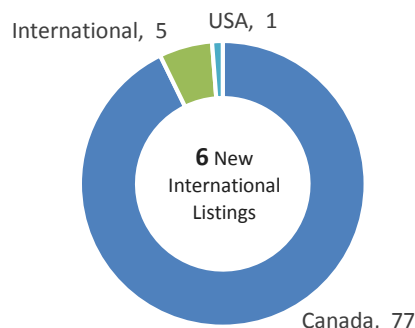

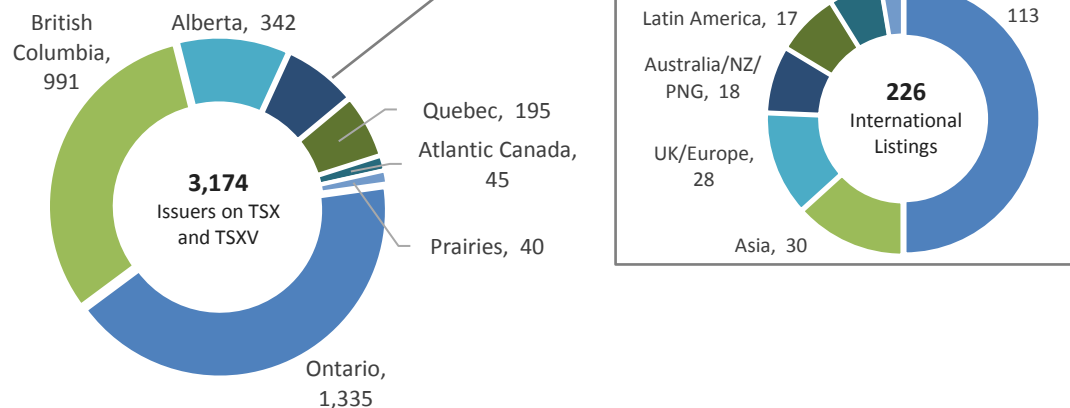

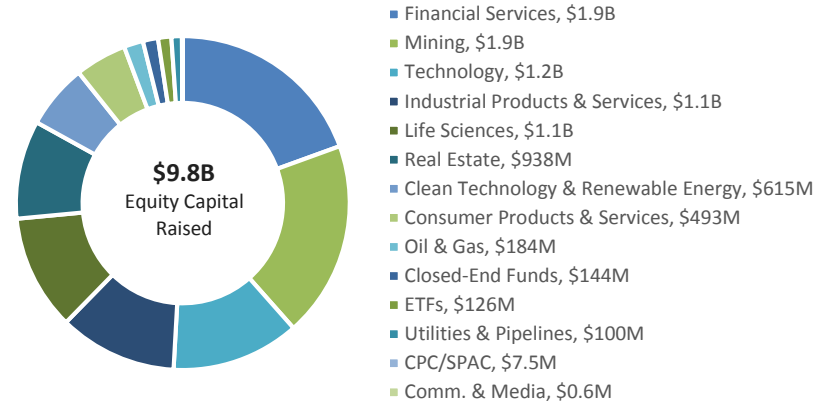

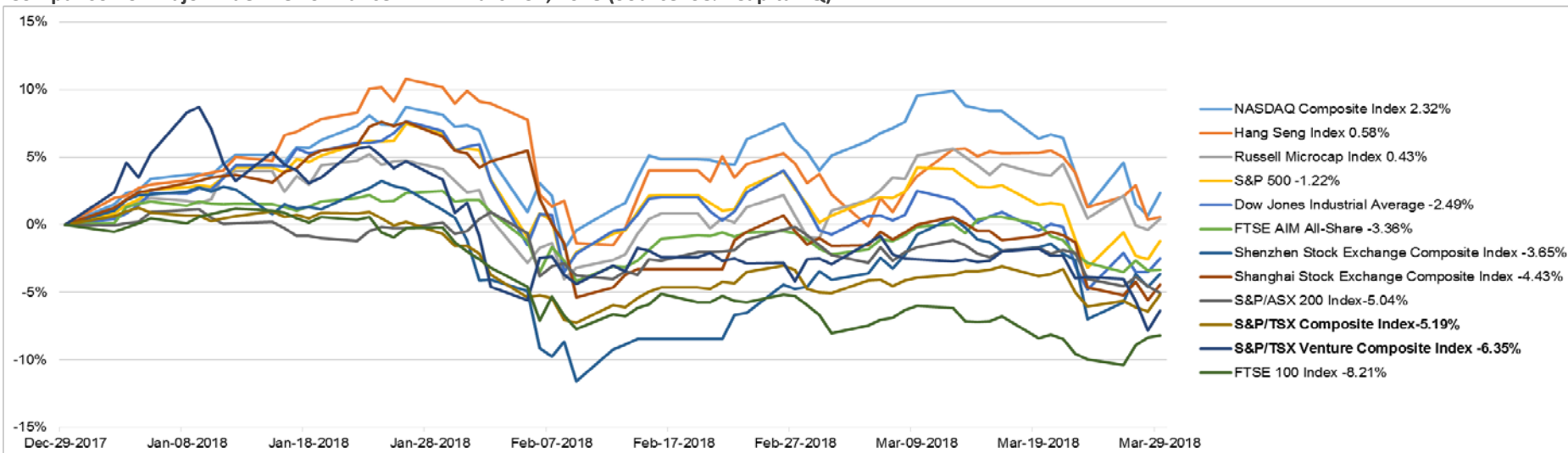

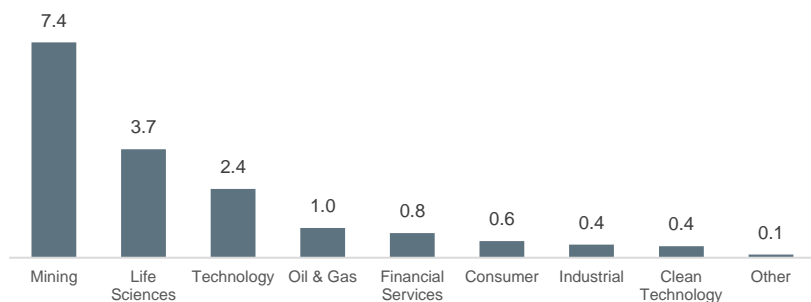
Comparison of Major Index Performance -- YTD March 31, 2018 (Source: S&P Capital IQ)



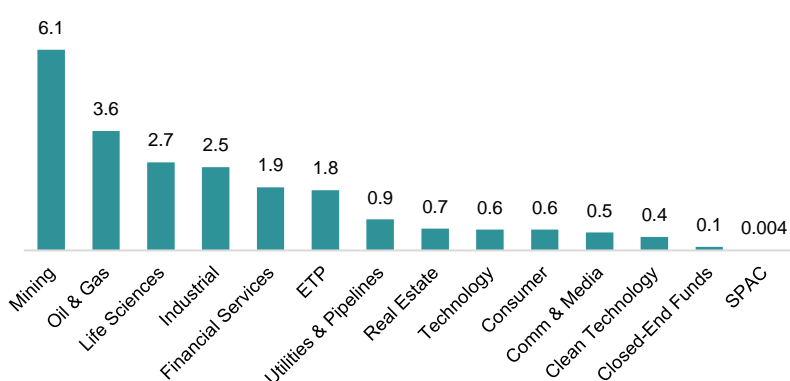
