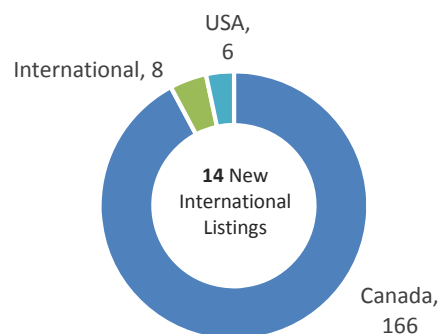

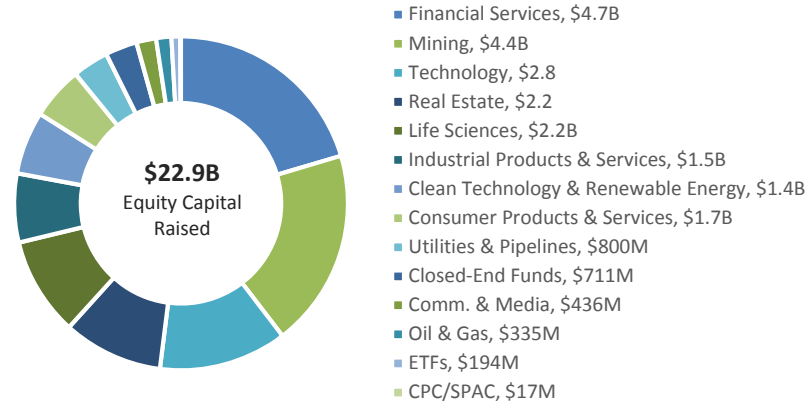

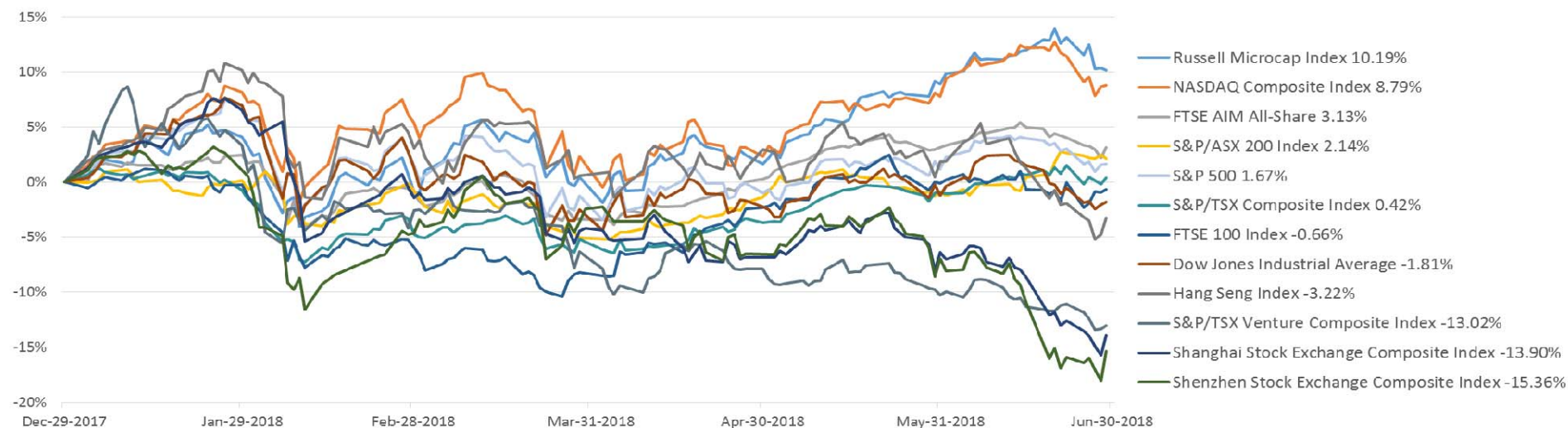

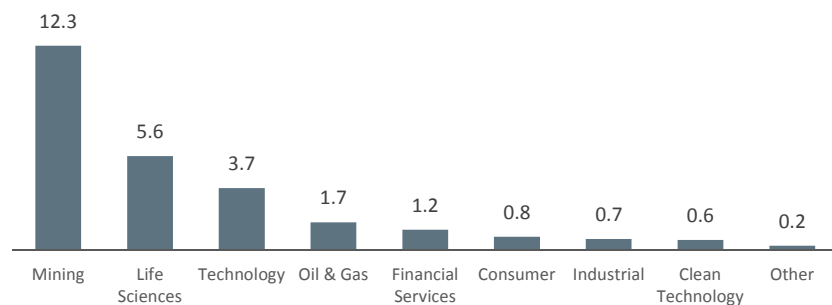
Comparison of Major Index Performance -- YTD June 30, 2018 (Source: S&P Capital IQ)



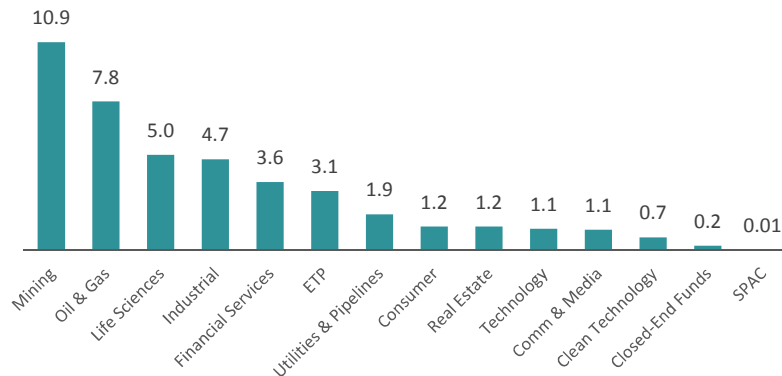
