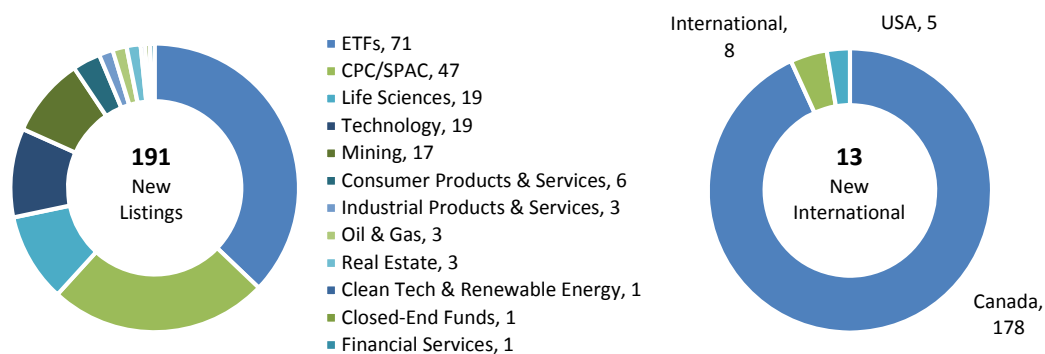

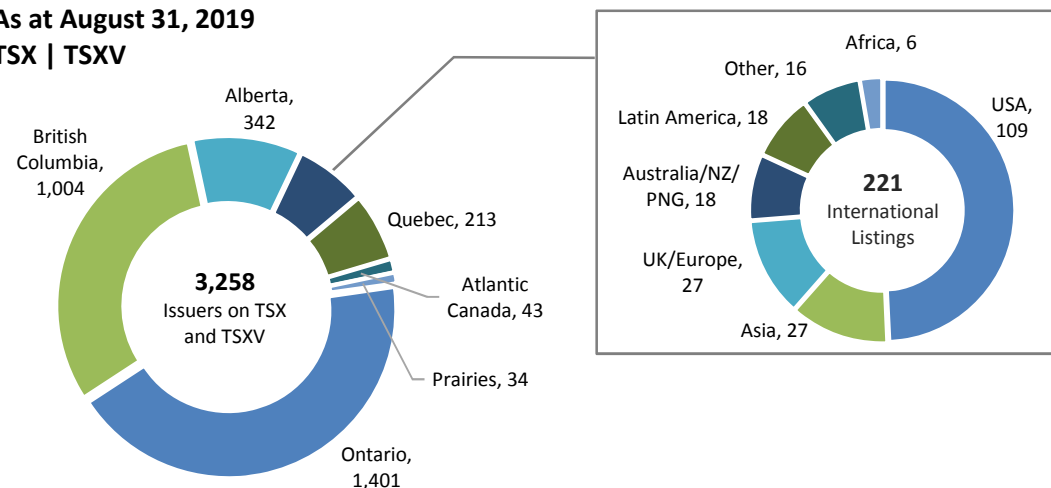

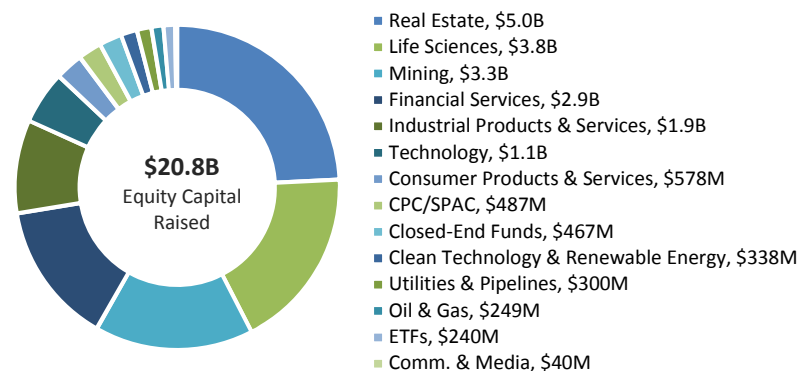

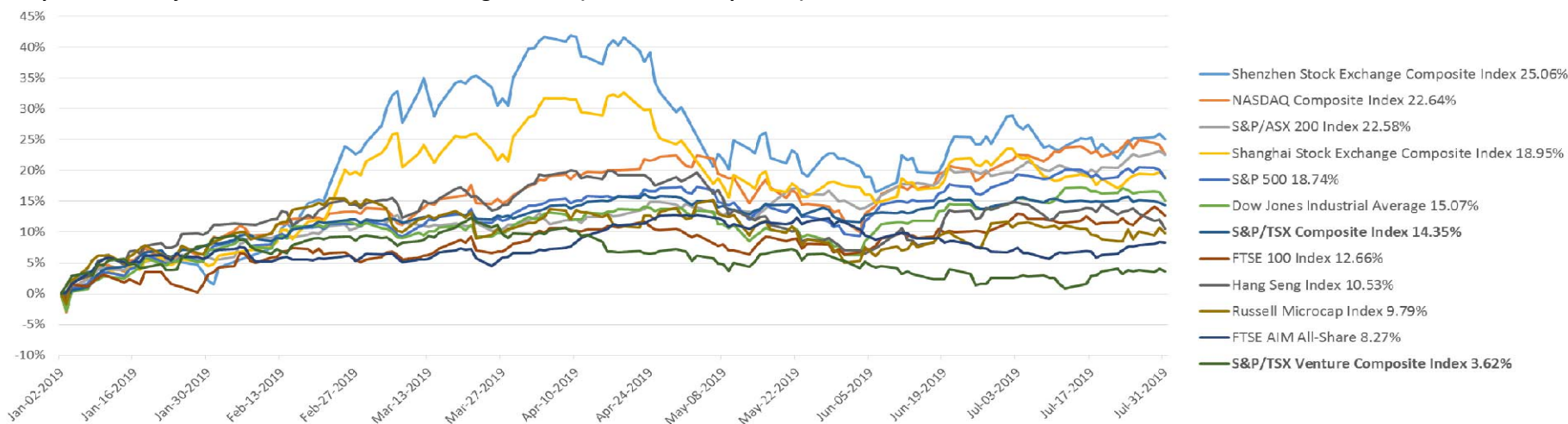

## Comparison of Major Index Performance -- YTD August 2019 (Source: S&P Capital IQ)

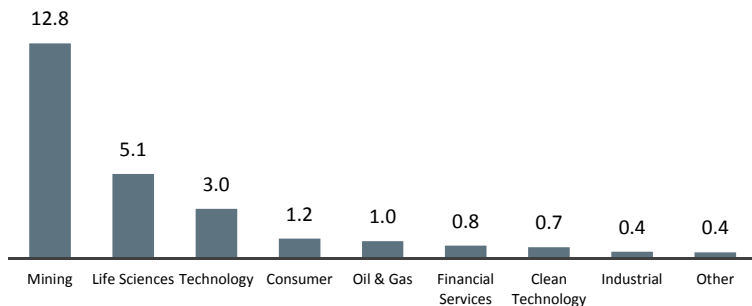

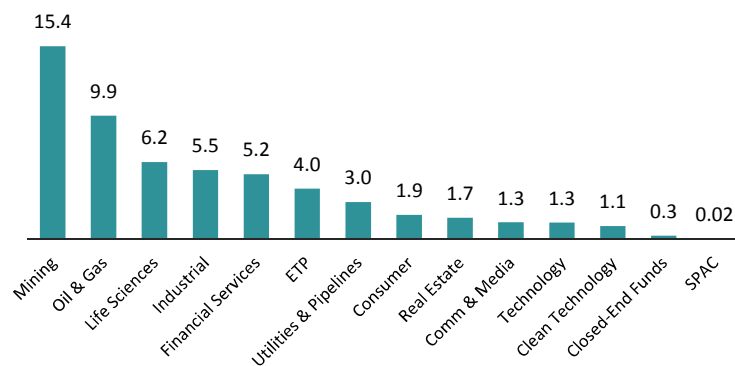
